The parts of the Bill cover: the health service in England; provision about public health; economic regulation of health and adult social services; NHS Foundation Trusts and NHS Trusts; public involvement and local government; primary care services; regulation of health and social care workers; the National Institute for Health and Care Excellence; health and adult social care services - information; abolition of certain public bodies; miscellaneous matters and final provisions. There are 22 schedules to the Bill.
